

MINUTES OF THE GENERAL MEETING OF THE PORT ELIZABETH BRANCH OF THE SOUTH AFRICAN FADIO LEAGUE HELD AT ST. MARTIN'S CHURCH, KABEGA PARK OM FRIDAY 20TH NOVEMBER, 1987.

<u>PRESENT:</u> 27 MEMBERS AND VISITORS. <u>APOLOGIES:</u> 2925 BK, BY, CG, MG, RG, AP AND RL.

THE CHAIRMAN WELCOMED ALL TO THE LAST MEETING OF THE YEAR AND REMINDED MEMBERS THAT THERE WOULD BE NO MEETING IN DECEMBER. A PARTICULAR WELCOME WAS EXTENDED TO BARRY JS2DT, STOFFEL JS2C, ALLAN JR2DL, TOFF JR2EY AND JOHN ZS2JR WHO WAS BACK FROM HIS OVERSEAS TRAVELS AND ALSO TO BARRY JR2AAB WHO HAD JOINED THE BRANCH AS A SOCIAL MEMBER.

MINUTES: THE MINUTES OF THE MEETING HELD 16TH OCTOBER, 1987, HAVING BEEN PRINTED AND CIRCULATED IN QSX-PE WERE TAKEN AS READ, PROPOSED BY LYNN ZSZMM AND SECONDED BY GUS ZSZMC.

ARISING:

<u>QORRES:</u> (1) SEVERAL ITEMS FOR QSX-PE WERE RECEIVED FROM JIM Z52LR.

(2) COPY OF LETTER FROM HQ TO ALGOA BRANCH.

ARISING: SEVERL QUESTIONS AROSE REGARDING THE ISSUE OF THE LICENCE FOR THE KAREEDOUW REPEATER. TREVOR ZSZAE REPLIED THAT IT HAD NOT BEEN ISSUED SPECIFICALLY FOR LINKING PURPOSES.

FINANCE: LYNN ZS2MM REPORTED THAT R1500 HAD BEEN INVESTED IN EXPANDING RATE CERTIFICATES. R100 HAD BEEN PAID FOR THE NATAL FLOOD RELIEF FUND ON BEHALF OF THE BRANCH.

GENERAL: (1) DARRYL ZS2CZ WAS ASKED TO EXTEND GOOD WISHES TO HIS XYL DAPHNE WHO HAD RECENTLY HAD A DOUBLE BY-PASS CREATION AND COLIN ZS2AO WHO WOULD BE GOING TO HOSPITAL NEXT WEEK FOR AM OPERATION WAS ALSO WISHED A SPEEDY RECUVERY.

(2) SEVERAL PAMPHLETS WERE AVAILABLE FOR VIEWING. THESE HAD BEEN EROUGHT BACK BY COR ZSZCG FROM A TRIP TO THE UNITED NATIONS AMATEUR STATION IN SENEVA AND ALSO AN EXHIBITION IN ENGLAND. COR UNFORTUNATELY COULD NOT ATTEND THE MEETING TONIGHT.

4 USEFUL HINT FOR HOME-BREWERS.

A PAD OF FINE STEEL WOOL IS AN EXCELLENT SOLDERING-IRON TIP CLEANER. THIS MATERIAL MAKES CLEANING THE ROSIN OFF THE TIP AN EASY MATTER, ESPECIALLY WHEN USING A SMALL PENCIL IRON TO ASSEMBLE PRINTED CIRCUITS. IF CAN BE LEFT ON THE WORK TABLE IN A CONVENIENT FLACE. THE IRON TIP CAN BE DRAWN ACROSS IT FROM TIME TO TIME, RESULTING IN A SHINY TIP READY FOR MAKING MANY CLEAN JOINTS. HEAT DOES NOT AFFECT THE STEEL WOOL AND SOLDER DOES NOT ADDRESS TO IT.

PROPOSED RESTRUCTURING OF THE S.A. RADIO LEAGUE IN ACCORDANCE WITH MOTION 27 ADOPTED AT THE 1985 ANNUAL GENERAL MEETING.

OPEN LETTER TO ALL MEMBERS OF THE PORT ELIZABETH BRANCH.

DEAR MEMBER.

THE FOLLOWING FOUR PAGES CONTAIN THE ENTIRE CONTENTS OF CORRESPONDENCE RECENTLY RECEIVED FROM LAURIE DEVEREUX ZSSDL, CHAIRMAN OF THE DURBAN BRANCH, MOST OF WHICH IS SELF-EXPLANATORY. WHILE THE FINER POINTS. OF WHICH THERE ARE A GREAT NUMBER TO CONSIDER, HAVE NOT BEEN COVERED, THESE WILL INDEED HAVE TO BE COVERED, BOTH BY US AS A BRANCH, AND BY THE DELEGATES TO THE 1988 ANNUAL GENERAL MEETING, WHERE I FORESEE A GREAT DEAL OF LENGTHY AND PROBABLY HEATED DEBATE ARISING, AND I FEEL THAT IT ABSOLUTELY ESSENTIAL THAT ALL THE DELEGATES ARE WELL ARMED WITH THE CORRECT MATERIAL WHICH CAN ONLY COME FROM YOU, THE MEMBERS. I INTEND TO RAISE AND COVER A FEW POINTS WHICH ARISE AS I SEE THIS PROPOSAL AND I APPEAL TO EACH AND EVERY ONE OF YOU TO CONSIDER THE PROPOSAL VERY CAREFULLY AS THE VERY EXISTENCE OF THE RADIO LEAGUE COULD WELL BE THREATENED BY AN ILL-ADVISED MOVE ON THIS PROPOSAL. THIS MATTER WILL HAVE TO BE DISCUSSED AT ONE OR MORE OF OUR BRANCH MEETINGS BEFORE THE ALG.M., BUT I WOULD VERY MUCH LIKE TO HAVE THE FEELINGS OF THE LARGE NUMBER OF OUR MEMBERS WHO DO NOT, OR CANNOT ATTEND BRANCH MEETINGS, PARTICULARLY THOSE WHO LIVE IN OTHER AREAS, AND I ASK THOSE MEMBERS TO GIVE THE MATTER SOME THOUGHT, AND LET ME HAVE YOUR OPINIONS IN WRITING PLEASE, AS THIS IS THE ONLY MAY WE WILL BE ABLE TO FORMULATE A DETAILED OVERVIEW OF THE FEELINGS OF THE MEMBERSHIP AS A WHOLE. I WOULD CERTAINLY LIKE TO HAVE THIS INFORMATION BY NO LATER THAN THE END

THE PROPOSED STRUCTURE OF THE UNIONS AND CLUBS IS IN KEEPING WITH OTHER RODIES, AND THE AMERICAN AND BRITISH RADIO LEAGUES HAVE SIMILAR SETUPS WHEREBY "STIVATE" CLUBS CAN BE AFFILIATED TO THE RESPECTIVE CONTROLLING BOOIES. AS THERE CAN BE NO COMPULSION TO BECOME AFFILIATED TO THE LEAGUE, THERE EXISTS A DANGER OF THE AMATEUR RADIO FRATERNITY EVENTUALLY CONSISTING OF LITTLE GROUPS OF PEOPLE ALL ACTING ACCORDING TO THEIR OWN WISHES, WITH NONE OF THEM CONTRIBUTING TO THE LEAGUE. THIS WILL RESULT IN THE LEAGUE CEASING TO EXIST IN DUE COURSE BECAUSE OF LACK OF FINANCIAL COMPORT. ESSENTIALLY WE, AS A LEAGUE, WILL HAVE TO RELY SOLELY ON THE (NDIVIDUALS MOTIVATION WHICH PRESENTLY CAKES AND RECASS HIM/HER A MEMBER OF THE LEAGUE AS IT PRESENTLY EXISTS. TO KEEP HIM/HER A MEMBER OF AN APEILLATED CLUB.

OF THE SECOND WEEK IN FEBRUARY SO THAT IT CAN BE CONSIDERED TOGETHER

WITH THE FEELINGS OF THE LOCAL MEMBERS.

COMSIDER THIS: WE HAVE 6 OR 7 MEMBERS AT FRESENT WHO ARE ALL EMPLOYED BY THE MUNICIPAL SLECTRICITY DEPARTMENT. UNDER THE PROPOSED SCHEME, THERE IS NO REASON WHY THEY SHOULD NOT FORM THE "P.E.M. AMATEUR PADIO CLUB" - 1F THEY DECIDED NOT TO AFFILIATE THEMSELVES TO THE LEAGUE, WE WOULD IMMEDIATELY LOSE THOSE MEMBERS. HOWEVER, THEIR SUBSCRIPTIONS WOULD PROBABLY BE A LOT LOWER THAN THE PROSENT S.A.R.L. RATE, AND THEY MIGHT ATTRACT MORE MEMBERS TO THEIR CLUB - IF THEY WERE AFFILIATED IT WOULD BENEFIT THE LEAGUE, BUT IF NOT, THOSE ADDITIONAL MEMBERS (SOME OF WHOM COULD VERY EASILY BE CURRENT MEMBERS OF THE BRANCH/LEAGUE) WOULD ALSO BE LOST TO THE LEAGUE. THIS WHOLE SCHEME IS GOING TO RELY VERY HEAVILY ON THE INDIVIDUALS LOYALTY TO THE CENTRAL BODY.

TO COVER A FEW NUMBERED FOINTS IN VARIOUS FARTS OF THE PROPOSAL:

ITEM 11 ON PAGE 9 - AFFILIATION FEE - AS THE INDIVIDUAL CLUBS WILL BE
PRIVATELY RUN BODIES WHO WILL DETERMINE THEIR OWN SUBSCRIPTIONS RATES,
IT WILL BE DIFFICULT TO ESTABLISH WHAT AMOUNT SHOULD BE PAID TO THE
UNION FOR AFFILIATION - I CAN ONLY SURMISE THAT IT WILL HAVE TO BE
BASED ON A PERCENTAGE OF THE CLUBS INCOME FROM SUBS. EVEN THIS WILL NOT
GUARANTEE THE UNION AND HENCE THE LEAGUE AN ADEQUATE INCOME.

ITEM 12 ON PAGE 9 - FUNCTIONS TO BE DELEGATED - SOME PRESENT FUNCTIONS OF THE LEAGUE AS OUTLINED ON PAGE 9 CAN INDEED BE PASSED ON TO OTHERS TO CONTROL, HOWEVER, THE QSL BUREAU WILL HAVE TO REMAIN A CENTRALISED OPERATION, NO-ONE CAN EXPECT DX BUREAUX TO SEND SEPARATE

PARCELS OF CARDS TO 4 OR MORE SEPARATE BUREAUX IN SOUTH AFRICA. ONCE THE DX CARDS ARE RECEIVED, THEY CAN BE SENT OUT TO THE UNIONS FOR LOCALISED DISTRIBUTION, BUT SOMEONE STILL HAS TO BE EMPLOYED AT HQ TO DO THE INITIAL DISTRIBUTION.

DO THE INITIAL DISTRIBUTION.

MOVING TO THE LIST OF FUNCTIONS OF HQ ON PAGE 9, ITEM 1 RE MEMBERSHIP LISTINGS WILL FALL AWAY AS AN HQ FUNCTION. ITEM 2 WILL HAVE TO BE KEPT AT LEAST IN PART, AS MENTIONED ABOVE. ITEM 3 WILL ALSO LARGELY HAVE TO BE KEPT AT HQ AS IMPORTATION OF BOOKS BY THE SEPARATE UNIONS WOULD PROBABLY NOT BE PRACTICAL AND WOULD RESULT IN HEAVY EXPENDITURE AS IT WOULD BE VERY DIFFICULT TO DETERMINE THE STOCK LEVEL TO ORDER TO ENSURE THAT MONEY DOES NOT GO TO WASTE IN UNSOLD ITEMS.

ITEM 4 COULD PROBABLY BE UNLOADED ONTO SOMEONE IN ONE OF THE UNIONS, BUT WOULD PROBABLY NEED TO FALL UNDER THE UMBRELLA OF LIAISON WITH THE POST OFFICE TO SOME EXTENT, WHICH (SEE ITEM 13 ALSO) I FEEL CANNOT BE

DONE INDEPENDENTLY BY SEVERAL PEOPLE FROM DIFFERENT REGIONS.

ITEM 5 -LICENCING OF REPEATERS -COULD WELL REVERT TO THE OLD SYSTEM -EACH UNION COULD HANDLE APPLICATIONS ETC. ON BEHALF OF CLUBS IN THE AREA. ITEM 6 -INTERNAL BOOKS, ETC. AGAIN I SEE THAT THIS WOULD IN THE FIRST INSTANCE HAVE TO BE A HQ FUNCTION, WITH DISTRIBUTION ONLY TO THE UNIONS BY HQ. ITEM 7 -SECRETARIAT - NO MATTER WHAT STRUCTURE WE ADOPT, HQ AS WELL AS EACH UNION AND CLUB WOULD HAVE TO RETAIN THIS FUNCTION.

ITEM 8 - I.A.R.U.- AGAIN A CENTRALISED FUNCTION ALTHOUGH NOT NECESSARILY A HQ FUNCTION. ITEM 9 - DIFFICULT ONE THIS. IF THE PRODUCTION OF A NATIONAL MAGAZINE WERE TO BE SPLIT UP BETWEEN VARIOUS REGIONS, WHICH WOULD PROBABLY BE A GOOD THING, SOMEONE STILL HAS TO ARRANGE THE MATERIAL, DO BATTLE WITH PRINTERS, POST IT ETC. THESE FINAL STAGES COULD NOT BE FRAGMENTED. ITEM 10 - NEWS BULLETINS - AGAIN THIS COULD BE DONE IN THE REGIONS. IN ORDER THAT ONE REGION IS NOT PERMANENTLY STUCK WITH THE JOB OF TRYING TO GET NEWS FROM FAR AND WIDE, POSSIBLY EACH UNION COULD PUT OUT ITS OWN BULLETIN, THE CURRENT NATIONAL BULLETIN WOULD THEN FALL AWAY, BUT THIS WOULD MEAN THAT ANY NEWS FROM HQ OF NATIONAL IMPORTANCE WOULD HAVE TO BE DISTRIBUTED TO EACH UNION FOR INCLUSION IN THEIR BULLETINS. ITEM 11 - CONTESTS - THIS IS LARGELY NOT A HQ FUNCTION NOW, AND COULD THEREFORE EASILY BE ARRANGED BY PERSONS IN OTHER AREAS...SOMEONE WOULD HAVE TO UNDERTAKE THE TASK OF HANDLING THE AWARDS CURRENTLY ISSUED BY HQ (ITEM 12).

ITEM 13 - LIAISON - I DOUBT THAT THIS COULD BE FRAGMENTED AMONGST REGIONS. ONLY RECENTLY WAS A SCHEME INTRODUCED WHEREBY HQ WOULD UNDERTAKE ALL DEALINGS WITH THE POST OFFICE IN ORDER TO RELIEVE THEM OF HAVING TO DEAL WITH ALL AND SUNDRY. ITEM 14 - HAMNET - PROBABLY COULD BE UNDERTAKEN BY SOME WILLING PERSON IN ONE OF THE UNIONS, POSSIBLY DOING THE ROUNDS EVERY YEAR OR TWO TO SPREAD THE BURDEN. ITEM 15 -

INTRUDER WATCH - SEE MY COMMENTS FOR ITEM 14 ABOVE.

ITEM 16 - CALLBOOK - THIS WOULD HAVE TO BE DONE MAINLY BY THE BODY WHO LIAISES WITH THE POST OFFICE, BUT WOULD ALSO PROBABLY NEED TO BE HANDLED BY WHOEVER DEALS WITH THE PRINTERS FOR RADIO-ZS - IT COULD BE PRINTED ANYWHERE ELSE OF COURSE.

THE ABOVE ARE JUST A FEW THOUGHTS I HAVE HAD ON THE MATTER. I AM SURE THAT THOSE WHO GIVE SOME TIME TO THE PROPOSAL WILL COME UP WITH MANY MORE, AND I NEED TO HAVE THAT INFO FROM YOU--P L E A S E !!!!!!!! REMEMBER THAT THE OUTCOME OF THE DECISIONS ON THIS PROPOSAL COULD BRING ABOUT DRAMATIC CHANGES WHICH WE COULD BE STUCK WITH FOR A LONG TIME, FOR BETTER OR WORSE.

HEREWITH AN ADVANCE COPY OF OUR PROPOSAL SUBMITTED FOR CONSIDERATION AT THE 1988 A.G.M. OF THE LEAGUE.

WE BELIEVE THAT THE TIME IS NOW RIGHT FOR A DRASTIC CHANGE IN THE STRUCTURE OF THE LEAGUE TO STREAMLINE THE FUNCTIONS AND PROVIDE GREATER PARTICIPATION BY ALL BRANCHES IN THE RUNNING OF THE LEAGUE. ALSO OF PARAMOUNT IMPORTANCE IS THE COST OF MEMBERSHIP ESPECIALLY ON BRANCH OR CLUB LEVEL.

THE PROPOSAL IS A BROAD OUTLINE OF THE SUGGESTED RE-STRUCTURING, AS TO PRO-VIDE THE SMALLEST DETAIL WOULD HAVE BEEN A COLOSSAL UNDERTAKING RUNNING INTO MANY PAGES. THE ADOPTION OF SUCH A PROPOSAL WOULD NECESSITATE A COM-PLETE REVISION OF THE CONSTITUTION, A TASK WHICH CAN BE DONE IN A VERY SHORT TIME AFTER APPROVAL OF THE MOTION.

WE ASK YOU TO STUDY OUR MOTION THOROUGHLY AND WITH AN OPEN MIND. THE BEST INTERESTS OF THE LEAGUE ARE FOREMOST IN OUR THOUGHTS IN PROPOSING THIS MOTION.

COPY OF LETTER TO HEADQUARTERS.

DEAR SIR,

AT A PROPERLY CONSTITUTED MEETING OF THIS BRANCH HELD ON MONDAY 9TH NOV-EMBER 1987, IT WAS UNANIMOUSLY DECIDED TO PROPOSE THE FOLLOWING AMENDMENTS TO THE CONSTITUTION OF THE S.A. RADIO LEAGUE:

THE MOTION IS MADE IN TERMS OF A MOTION, MOTION 27, PASSED AT THE ANNUAL GENERAL MEETING HELD IN PRETORIA IN 1985. THAT MOTION AS PASSED MEANT THAT THE S.A. RADIO LEAGUE WAS TO BE RESTRUCTURED BUT THAT THE MANNER IN WHICH THIS WAS TO BE DONE WAS TO BE DECIDED AT A LATER DATE.

THE PROPOSAL OF THIS BRANCH IS:

- 1. FOR THE PURPOSES OF THE RESOLUTION TAKEN (MOTION 27) THAT WHEREVER NECESSARY THE CONSTITUTION OF THE S.A. RADIO LEAGUE BE SUITABLY AMENDED TO PROVIDE THE NECESSARY CHANGES.
- 2. THAT THE S.A. RADIO LEAGUE BE DIVIDED INTO THE FOLLOWING TIERS:
 - (A) THE SOUTH AFRICAN RADIO LEAGUE COUNCIL
 - (B) AFFILIATED UNIONS
 - (C) AFFILIATED CLUBS
- 3. THAT THE S.A. RADIO LEAGUE (HEREINAFTER REFERRED TO AS THE "LEAGUE") COUNCIL COMPRISE OF:
 - (A) PRESIDENT
 - (B) VICE PRESIDENT
 - (C) SECRETARY/TREASURER
- (D) THE CHAIRMEN OF ALL AFFILIATED UNIONS
 - 4. THAT THE VARIOUS UNIONS COMPRISE OF:
 - (A) CHAIRMAN
- (B) VICE CHAIRMAN
 - (C) SECRETARY/TREASURER
 - (D) MEMBERS COMPRISING REPRESENTATIVES OF ALL AFFILIATED CLUBS.
- 5. THAT ALL AFFILIATED CLUBS BE SELF- CONSTITUTED ALONG THE LINES NORMALLY LAID DOWN FOR THE PROPER RUNNING OF A CLUB.
- 6. THAT THE COUNCIL OF THE LEAGUE HOLD THREE GENERAL MEETINGS PER ANNUM, PREFERABLY AT A CENTRAL VENUE. ONE OF SUCH GENERAL MEETINGS SHALL BE THE ANNUAL GENERAL MEETING. ALL SUCH MEETINGS SHALL NOT BE HELD OVER HOLIDAY SASON WEEKENDS, SO AS TO ENSURE THAT ALL SUCH MEETINGS' EXPENSES BE KEPT TO A MINIMUM.
- 7. THAT THE AFFILIATED UNIONS HOLD AT LEAST FOUR GENERAL MEETINGS PER ANNUM ONE OF WHICH SHALL BE THE ANNUAL GENERAL MEETING AND BE HELD AT A CENTRAL VENUE IN THE AREA OF THE UNION.

ALL AFFILIATED CLUBS SHALL HOLD SUFFICIENT MEETINGS FOR THE PROPER RUNNING OF THE CLUBS.

9. THE AREA OF JURISDICTION OF THE UNIONS SHALL BE THE SAME AS THOSE LAID DOWN IN OTHER SPORTS SUCH AS THE S.A. CRICKET ASSOCIATION OR THE S.A. RUGBY BOARD AS AGREED TO BY THE ANNUAL GENERAL MEETING AT THE TIME OF THE ACCEPT-ANCE OF THIS PROPOSAL.

10. ALL AFFILIATED CLUBS SHALL PAY AN AFFILIATION FEE BASED ON THE NUMBER OF MEMBERS BELONGING TO THE CLUB, TO THE UNION TO WHICH SUCH CLUB BELONGS AND THE UNION IN TURN SHALL PAY TO THE LEAGUE AN AFFILIATION FEE BASED ON THE MEMBERSHIP OF THE UNION.

11. ANY SUCH AFFILIATION FEE SHALL BE KEPT TO THE ABSOLUTE MINUMUM RE-

QUIRED FOR THE PROPER RUNNING OF BOTH THE UNION AND THE LEAGUE.

12. THAT ALL THE FUNCTIONS OF THE LEAGUE SHALL WHEREVER POSSIBLE, BE KEPT TO A MINIMUM AND THAT AS MANY FUNCTIONS AS POSSIBLE BE DELEGATED TO THE UNIONS BEST SUITED TO HANDLE SUCH FUNCTIONS. (THIS WILL ENSURE THAT THE LEAGUE IS NOT ENCUMBERED WITH WORK WHICH CAN BE DELEGATED TO A UNION.)

13. CLUBS SHALL DETERMINE THE AMOUNT OF ANY FEES OR SUBSCRIPTIONS PAYABLE BY MEMBERS TO SUCH CLUB WITH DUE ACCOUNT BEING PAID TO PARA. 10 HEREOF.

14. THAT THE PROPOSALS OUTLINED IN PARAS. 1 TO 13 ARE THE BROAD OUTLINE OF THE RESTRUCTURING PROPOSAL AND THAT THE OMISSION OF ANY SPECIFIC ITEM SHALL NOT INVALIDATE THE PROPOSAL. ANY SUCH OMISSION SHALL BE DECIDED UPON AT THE ANNUAL GENERAL MEETING PROVIDED THAT SUCH PROPOSAL SHALL BE IN KEEPING WITH THE SPIRIT OF THIS PROPOSAL.

MOTIVATION.

THIS PROPOSAL IS DESIGNED TO STREAMLINE THE LEAGUE AND SHARE THE BURDEN OF THE RUNNING OF THE LEAGUE AMONGST A FAR BIGGER PORTION OF THE MEMBERSHIP THAN AT PRESENT.

THIS PROPOSAL IS DEFINITELY NOT INTENDED TO BREAK UP OR FRAGMENT THE LEAGUE IT IS MOST UNFAIR THAT ANY ONE SMALL PART OF THE MEMBERSHIP OF THE LEAGUE BE EXPECTED TO UNDETAKE THE SOLE RESPONSIBILITY OF RUNNING THE AFFAIRS OF THE LEAGUE AS IS THE CASE AT THE PRESENT TIME.

THE PRESENT STRUCTURE WILL, WITH AN INCREASE IN MEMBERSHIP AND RUNNING COSTS WHICH IT IS EXPECTED WILL ESCALATE AT AN ALARMING RATE IN THE FUTURE, CREATE A HEAVY FINANCIAL BURDEN ON MEMBERS IN PURSUANCE OF THEIR HOBBY. HAVING STATED THE ABOVE IT IS STRESSED THAT THIS PROPOSAL IS NOT INTENDED TO CONVEY ANY THOUGHT THAT THE PRESENT COUNCIL OR ITS FORERUNNERS HAVE EVER DONE ANYTHING WHICH, IN THEIR OPINION, WAS NOT IN THE BEST INTEREST OF THE

WHILST THESE ARE BASIC REQUIREMENTS, THERE ARE MANY OTHER MATTERS REQUIRING FINANCE TO ENABLE THEM TO FUNCTION PROPERLY.

AS CAN BE SEEN FROM THE FOREGOING THERE IS A GREAT DEAL OF DUPLICATION OF FUNCTION AND AS A RESULT THE PRESENT SYSTEM HAS BECOME EXPENSIVE TO ADMINISTER AND THIS TREND WILL NO DOUBT CONTINUE IN THE FUTURE.

THE ADOPTION OF THE SUGGESTED RE-STRUCTURING WILL PLACE THE WORK AND THE ADMINISTATION RIGHT WHERE IT BELONGS - WITH THE CLUBS LEAVING THE LEAGUE TO CO-ORDINATE THE FUNCTIONS AND PROVIDE THE NECESSARY DIRECTION FOR AMATEUR RADIO IN THE REPUBLIC.

THIS SYTEM IS NOT NEW TO SOUTH AFRICAN SPORTS AND HOBBIES. AN EXCELLENT COMPARISON CAN BE FOUND IN THE S.A. RACING PIGEON SPORT, S.A. RUGBY, S.A. CRICKET, S.A. HOCKEY AND NUMEROUS OTHERS. IN ALL THESE SPORT TYPES, THE S.A. BODY DEALS ONLY WITH THE VARIOUS UNIONS AND THE UNIONS IN TURN DEAL WITH THE CLUBS. FROM THE CLUB ADMINSTRATION VIEW THERE IS FAR GREATER AUTONOMY AND A LOT LESS CLERICAL WORK.

NATURALLY THE LEAGUE AND UNIONS WILL HAVE LIMITED FINANCIAL RESOURCES BUT SURELY THIS IS A GOOD THING. THERE WILL BE NO NECESSITY TO HAVE EXPENSIVE OFFICE AND MEETING ACCOMODATION. THESE BODIES WILL ALSO BE ABLE TO PROVIDE ADDITIONAL FUNDS VIA THE SALE OF VARIOUS ITEMS PREVIOSLY STATED, AT A REASONABLE PROFIT.

THE UNIONS CONCERNED WILL ALL BE VERY NEAR ALL THE CLUBS IN THE UNION AREA, MAKING COMMUNICATION FAR EASIER. THE UNIONS WILL ALSO PROVIDE FAR GREATER REPRESENTATION FOR ALL CONNECTED WITH AMATEUR RADIO THAN AT PRESENT. THIS IS MOST IMPORTANT AS AT THE PRESENT TIME THERE IS A GRADUAL WIDENING OF THE COMMUNICATION GAP BETWEEN THE BRANCHES AND HEADQUARTERS.

ALL THE UNIONS WILL BE IN A GOOD POSITION TO CONDUCT NEGOTIATIONS WITH PRO-VINCIAL AND REGIONAL SERVICES AS WELL AS ALL LOCAL AUTHORITIES. THIS IS AN EXTREMELY IMPORTANT FUNCTION THAT CANNOT REALLY BE UNDERTAKEN FROM A LONG WAY AWAY. IT IS ALWAYS BETTER TO BE ABLE TO NEGOTIATE WITH THESE VARIOUS BODIES ON A PERSONAL BASIS RATHER THAN BY LETTER WRITING.

IN REGARD TO THE QSL BUREAU THE UNIONS CAN PLAY AN IMPORTANT PART BY OPERA-TING UNION QSL BUREAUX IN CONJUNCTION WITH THE LEAGUE BUREAU THEREBY CUTTING COSTS APPRECIABLY.

A STUDY OF ALL THE ASPECTS OF THIS PROPOSAL WILL INDICATE THAT A CHANGE IN THE STRUCTURE OF THE LEAGUE IS NOT ONLY POSSIBLE BUT IN THE INTERESTS OF ALL RADIO AMATEURS BOTH IN AND OUT OF THE LEAGUE AND I AM CERTAIN THAT SHOULD THE RE-STRUCTURING BE ACCEPTED A LARGE NUMBER OF NON-MEMBERS WILL JOIN THE CLUBS IN THEIR OWN AREAS AND THE EFFECT OF THIS INFLUX OF MEMBERS WILL BENEFIT AMATEUR RADIO CONSIDERABLY. THE GREATER REPRESENTATION FIGURE WILL ENHANCE THE STATUS OF THE LEAGUE.


